We perform in house daily calibration and verification on all our spirometry devices and the manufacturers perform a yearly service.

Southport and Ormskirk:

In-House Calibration.

St Helens and Knowsley:

No, equipment is temperature sensitive and may require re-calibration – can use verification. We do use pre-calibrated pneumotachographs which we perform verification on.
