Drug Overdoses

REQUEST

Under the Freedom of Information Act 2000, I would like to ask for the following information regarding drug overdoses and would like the information broken down by hospital site. If this is not possible, please state that the data at Trust level.

- 1. How many admissions related to drug overdose for year 2022?
- 2. How many admissions related to drug overdose from Jan Nov 2023?
- 3. What are the most common drug overdose cases admitted in your hospital?
- 4. How many patients admitted for drug overdose received medical treatment at a ward level 2022?
- 5. How many patients admitted for drug overdose received medical treatment at a ward level Jan Nov 2023?
- 6. How many patients admitted for drug overdose required admission to the intensive care unit for advanced medical intervention such as mechanical ventilation and continuous renal replacement therapy in 2022?
- 7. How many patients admitted for drug overdose required admission to the intensive care unit for advanced medical intervention such as mechanical ventilation and continuous renal replacement therapy in Jan Nov 2023?
- 8. What is the average length of stay for those patients admitted for drug overdose in your intensive / critical care unit?
- 9. What is the total number of deaths related to drug overdose in your hospital in 2022?
- 10. What is the total number of deaths related to drug overdose in your hospital Jan Nov 2023?

Clarification:

Please could you confirm if you are interested in looking at accidental overdoses, intentional overdoses or adverse effect in therapeutic use etc?

Any overdose, whether that be intentional or accidental rather than adverse effect in therapeutic use. It could be over the counter drugs, prescription drugs or illicit substances.

In addition, please could you clarify if there are any other procedures that you consider to be "advanced medical intervention" other than mechanical ventilation and continuous renal replacement therapy?

It would relate to any admission to Critical Care (ICU/HDU), no specifics on treatments received would be required, just the number admitted to ICU following a drug overdose as presumably the patient would receive advanced medical intervention in critical care that they couldn't receive on the ward.

RESPONSE

St Helens and Knowsley Teaching Hospitals NHS Trust and Southport and Ormskirk Hospital NHS Trust became a single legal entity known as Mersey and West Lancashire Teaching Hospitals NHS Trust on 1st July 2023, as such parts of the response may be provided in two sections relating to the hospital sites of each of the legacy organisations.

Section 40: personal information

We are unable to provide precise figures when those figures refer to individuals in volumes of 5 or less due to the risk that individuals will be reidentified, as we are required to protect their identity under the General Data Protection Regulations & Data Protection Act 2018. In such

circumstances Section 40(2) and Section 40(3) of the Freedom of Information Act apply. In this case, our view is that disclosure would breach the first data protection principle which states that personal data should be processed "lawfully, fairly and in a transparent manner". It is the lawful aspect of this principle which, in our view, would be breached by disclosure, and in such circumstances, Section 40 confers an absolute exemption on disclosure.
